**3. DISCUSSION REGARDING AMENDING THE TOWN'S MARIJUANA LICENSE FEES (10 Minutes)** Local marijuana cultivation operators have requested that the Town Board consider reducing the annual license fees, last revised in 2016, in response to competition from outdoor cultivation operations.

**4. CONSIDERATION OF RESOLUTION 2023-002 RATIFYING THE APPOINTMENT OF A MEMBER TO THE SOUTH ROUTT LIBRARY DISTRICT BOARD OF TRUSTEES (5 Minutes)** The South Routt Library District Board of Trustees unanimously recommends the appointment of Meribeth Smith to a 5-year term to the Library District Board.

CONSIDERATION OF RESOLUTION 2023-003 AMENDING RESOLUTION 2022-020 APPROVING THE PURCHASE OF LOTS 17, 18, 19 AND 20, AND ANY ADJACENT PARTIALLY VACATED ALLEY LAND, BLOCK 2, 2<sup>ND</sup> ADDITION TO OAK CREEK FROM THE ROUTT COUNTY FOUNDATION FOR SENIOR CITIZENS, INC. (5 Minutes)** The Town Board adopted Resolution 2022-020 ("Resolution") for the acquisition of certain property; and the Town Board will consider amending the Resolution to describe the property to be acquired as set forth in the title commitment.
