3. LAND USE CHANGE OF MINOR IMPACT, SIERRA VIEW SUBDIVISION, LOT 15, AKA 125 OAK RIDGE CIRCLE (20 Minutes) Continued Public Hearing, review and consideration of an application for a Land Use Change of Minor Impact for the development of four duplex structures.

4. CONSIDERATION OF RESOLUTION 2023-012 TO APPROVE A TRASH & RECYCLING AGREEMENT WITH WM, AKA WASTE MANAGEMENT (10 Minutes) Town staff and attorneys have prepared a five (5) year contract agreement with Waste Management (WM), subject to annual appropriation by the Town Board, for residential trash and recycling services for all residential structures within the Town limits with five (5) or fewer residential units. The proposed contract will become effective November 1, 2023 with the first pickup by WM on Tuesday, November 7, 2023.

CONSIDERATION OF A REQUEST TO REVISE A RESUBDIVISION OF LOTS 2-6, BLOCK 6, TOWN OF OAK CREEK, AKA LUPITA'S SUBDIVISION (10 Minutes) Property owners seek to revise subdivision previously sought by them and subsequently approved by the Town Board on January 12, 2023, by subdividing the lots along the Lot 3 and Lot 4 lot line.

6. CONSIDERATION TO APPROVE THE RENEWAL OF A RETAIL LIQUOR LICENSE FOR OAK CREEK COMMUNITY PARTNERS, LLC DBA THE OAK CREEK TAVERN, TO SELL AT RETAIL MALT, VINOUS AND SPIRITUOUS LIQUOR AT 105 E.
